## 2020 VIRTUAL ANNUAL GENERAL MEETING – ATTENDANCE GUIDE

All resolutions at the AGM will be voted on by poll and Shareholders who are entitled to vote may vote either prior to the Meeting by appointing a proxy or by poll during the Meeting (which will be taken electronically). Shareholders are strongly encouraged to either vote prior to the Meeting or to appoint the Chair of the Meeting as their proxy.
