Talga Resources Ltd ("Talga" or "the Company")(ASX:TLG) is pleased to advise that pursuant to ASX Listing Rule 3.13.2, the outcomes of each resolution put to shareholders at the Annual General Meeting held on 12 November 2020 at 2.30pm (AWST).

Resolutions 1, 2, 4, 5, 6 and 7 were passed on a poll. Resolution 3 (10% placement facility) was withdrawn at the meeting as the Company no longer constitute an "eligible entity" for the purposes of Listing Rule 7.1A, due to Talga's market capitalisation now exceeding A\$300 million.
