Noronex Limited – (ASX: NRX) – Formerly Lustrum Minerals Ltd – Anticipated Reinstatement to Official Quotation

Description

The securities of Noronex Limited ('NRX') are expected to be reinstated to Official Quotation at the commencement of trading at 10:06:45am AEDT on Wednesday, 18 November 2020, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules. NRX raised \$4,300,000 pursuant to the offer under its prospectus dated 15 September 2020 ('Prospectus') by the issue of 86,000,000 shares at an issue price of \$0.05 per share.
