Allotment of \$1.4m Rights Issue

Pursuit Minerals Limited (ASX:PUR) ("Pursuit" or the "Company") is pleased to announce that it has completed the rights issue with the issue of 157,411,423 fully paid ordinary shares (**Shares**) to shareholders and clients of CPS Capital (**Rights Issue**).

The Shares were issued with an issue price of \$0.009 per Share, raising \$1,416,703 (before costs).

CPS Capital was paid a cash fee equal to 6% of the amount raised. Further details relating to the issue of the Shares are set out in the Appendix 2A and 3Y's as attached.

Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001

The Corporations Act 2001 ("Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the issue of the Shares will fall within the exemption in section 708A(5) of the Act.

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Corporations Act"), the Company gives notice that:
