

GOLDEN SWAN AND SOUTHERN TERRACE CONTINUES TO GROW

19 NOVEMBER 2020

HIGHLIGHTS

- Drill hole PBSD0029D has intersected a strongly mineralised interval of 6.4m (3.7m true width) of massive/matrix nickel sulphides
- This intersection continues a series of high quality nickel sulphide intersections returned at Golden Swan over a 170m dip extent
- The combination of thick, high grade intersections at Golden Swan in combination with the untested Downhole Electromagnetic conductors in the greater Southern Terrace position, underscores the opportunity for the Company to rapidly build high grade nickel resources once the drill drive is completed

Poseidon Nickel (ASX: POS, "the Company") is pleased to advise that drill hole PBSD0029D has intersected a 6.8 metre (3.9m true width) interval of nickel sulphides from 650m down hole (refer to Table 1 and Figure 2 for details). The latest intersection is 50m up plunge of hole PBSD0030B which returned 9m (4.5m true width) at 10.46% Ni and 100m up dip of PBSD0029A which intersected 7.6m @ 8.8% Ni (4.3m true width) - see ASX releases dated 18 August 2020 (Golden Swan assays confirm exceptional drill intersection) and 12 October 2020 (DHEM Targets Expands Golden Swan Potential).




FIGURE 1 - LOCATION OF THE LATEST INTERSECTION (HOLE PBSD0029D) ON THE SOUTHERN TERRACE

The core had been geologically logged and will now be cut and assayed. The intersection occurred at the contact between the Black Swan mineralised komatiite flow and the underlying felsic unit. The stratigraphic contact is termed the "Southern Terrace" and was identified as a significant exploration opportunity by the Company, just 300m to the South of the Silver Swan workings.

This latest and highest intersection confirms that the additional Downhole Electromagnetic (DHEM) responses announced on 12 October 2020 are due to the presence of nickel sulphides (refer Figure 1). Hole PBSD0029D may also indicate that the previously identified separate DHEM plates outlining the known Golden Swan mineralisation are a continuous horizon of nickel sulphides accumulating upon the Southern Terrace.




Poseidon's MD & CEO Peter Harold commented, "This is another outstanding drill result at Golden Swan and demonstrates the enormous potential of the Southern Terrace. The Company has committed to the Golden Swan Drill Drive and WestAuz Mining is in the process of mobilising to site with the first cut on track for early December. Tender submissions for the resource drilling contract are due on 20 November, with strong interest shown. The new drill drive we also be an ideal position to drill test the Southern Terrace and see if there are additional mineralised zones. We are also in a unique position to be able to drill out the Golden Swan mineralisation quickly and then determine the most appropriate way to exploit this mineralisation, should it prove to be economic."

Poseidon Nickel Limited (ASX Code: POS) is a nickel sulphide exploration and development company with three projects located within a radius of 300km from Kalgoorlie in the Goldfields region of Western Australia and a resource base of around 400,000 tonnes of nickel and 180,000 ounces of gold.

Poseidon's strategy is focused on the exploration and eventual restart of its established nickel operations in Western Australia where project risk capital and operating costs are low. A critical element of this strategy has been to acquire projects and operations with high levels of geological prospectivity likely to lead to potential substantial extension of the operation's life through the application of modern exploration techniques.

Poseidon owns the Windarra, Black Swan and the Lake Johnston Nickel Projects. In addition to the mines and infrastructure including concentrators at Black Swan and Lake Johnston, these projects have significant exploration opportunities demonstrated by the discovery of the Abi Rose deposit at Lake Johnston and the recent discovery of the Golden Swan mineralisation at Black Swan. The Company is also undertaking a Definitive Feasibility Study on retreating the gold tailings at Windarra given the strength of the A\$ gold price.

Relationship Between Mineralisation Widths and Intercept Lengths

These relationships are particularly important in the reporting of Exploration Results. True widths are stated where necessary.

If the geometry of the mineralisation with respect to the drill hole angle is known, its nature should be reported.

If it is not known and only the down hole lengths are reported, there should be a clear statement to this effect (eg 'down hole length, true width not known').
