### TRADING HALT REQUEST

In accordance with Listing Rule 17.1, Roto-Gro International Limited (ASX: RGI) (**the Company**) requests an immediate voluntary trading halt of the Company's ordinary shares quoted on the Australian Securities Exchange (**ASX**).
