RESULTS OF ANNUAL GENERAL MEETING

The following information regarding the results of the Annual General Meeting of Ardiden Limited held on 26 November 2020 is provided in accordance with Listing Rule 3.13.2 and section 251AA(2) of the Corporation Act.

Resolutions 9 through to 14 inclusive were withdrawn prior to the meeting and were not put to shareholders. The withdrawal of the resolutions was due to a combination of the reduction in Ardiden's market capitalisation since the Notice of Annual General Meeting was issued together with shareholder feedback and proxy results received prior to the meeting. A description of each of the withdrawn resolutions is set out overpage.

It is advised that all resolutions put to the meeting were carried via a poll. The detailed voting results in accordance with section 251AA(2) of the Corporation Act 200 are included overpage.

Resolution 6 was carried by a sufficient majority as a special resolution.
