#### PERFORMANCE RIGHTS APPROVED BY SHAREHOLDERS

Lynas Corporation Ltd (ASX:LYC, OTC:LYSDY) confirms that, during the AGM held on 26 November 2020, Shareholders approved Resolution 6 relating to a proposed award of Performance Rights. As set out in the 2020 AGM Notice, the Performance Rights that are now being awarded in accordance with Resolution 6 are as follows:

- 1. 55,695 FY20 STI performance rights for the benefit of Amanda Lacaze, the Lynas CEO and Managing Director. The STI Performance Rights have a 1 year vesting period. Further detail is provided in the remuneration report section of the FY20 financial report and in the 2020 AGM Notice.
- 2. 417,712 LTI Performance Rights for the benefit of Amanda Lacaze. The LTI Performance Rights have a three year vesting period and they are subject to vesting conditions relating to Total Shareholder Return and the Lynas Kalgoorlie Project. Further details are provided in the 2020 AGM Notice.

In addition, as part of the growth of the company, the Lynas senior management team has expanded to include new personnel. The Lynas Board has approved an award of 75,694 LTI Performance Rights to new senior managers on the same terms as were set out in the Lynas ASX announcement dated 24 September 2020.
