Completion of \$200,000 Placement

Pursuit Minerals Limited (ASX:PUR) ("Pursuit" or the "Company") is pleased to announce that it has completed the placement of 200,000 fully paid ordinary shares (**Placement Shares**) to the nominees of the vendor of the Warrior Project (**Placement**).

The Placement Shares were issued with an issue price of \$0.009 per Placement Share, raising \$200,000 (before costs).

The Company has further issued 5,000,000 shares to the S3 Consortium Pty Ltd (Stocks Digital) for nil cash consideration, topping up Stock Digital's marketing facility services with an additional \$67,500 worth of services at a deemed issue price of \$0.0135 per share ("**Marketing Shares**").

The Company issued the above shares out of its 7.1 placement capacity.
