**Greenland Minerals Ltd** ('GML' or 'the Company') is pleased to advise the completion of the capital raising of A\$30 million before costs, through the issue of 125,000,00 fully paid ordinary shares at A\$0.24 per share ('Placement'). The new shares will be issued under the Company's existing placement capacity under ASX Listing Rule 7.1.
