



Dropsuite Vesting of Performance Rights

10 December 2020: Global cloud backup and archiving software provider Dropsuite Limited (ASX: DSE) (“Dropsuite” or the “Company”) confirms that Board of Directors have resolved the issuance of 3,007,500 fully paid ordinary shares related to the performance rights granted under the Employee Long Term Incentive Plan (LTIP) for non-executive employees. Concurrently, 12,500 performance rights lapsed.

As announced to the market on 17 July 2019, the Board of Directors resolved to issue a total of 12.08 million performance rights for nil consideration to the Company’s non-executive employees under the terms of the Dropsuite 2019-2021 Performance Rights Plan (ref: ASX Announcement - 17 July 2019 - LTIP Performance rights).

In line with this announcement, the first tranche hurdles for these performance rights have been met being:

- The employees have been employed for a period of 12 months (until 1 July 2020) from the date of grant and;
- The share price achieved a 30-day volume weighted average price of at least AUD\$0.08 for a minimum of thirty days on November 25, 2020.

The performance rights were implemented with the aim of improving team performance and commitment by providing meaningful long-term rewards that were aligned with business performance and shareholder value. The performance rights were primarily issued to employees who joined the Company *after* it went public and who have not been awarded any LTIs previously. At the time of granting these performance rights, Dropsuite share price was approximately \$0.03.

Dropsuite’s Chairman Theo Hnarakis stated: “We are pleased to be able to reward the continued commitment and performance of our employees for helping deliver shareholder value. The performance and customer engagement remains strong and the Company is on track to deliver a strong finish to 2020.

“We continue to see solid opportunities ahead as we move steadily towards cashflow breakeven and we look forward to updating the market further in January when we release our quarterly results.”
