COMPLETION OF PLACEMENT APPENDIX 2A AND CLEANSING NOTICE

Wiluna Mining Corporation Limited ("Wiluna Mining" or "the Company") advises the completion of the issue of 15,776,767 ordinary fully paid shares ("Shares") at \$1.43 per share to raise approximately \$22.55 million, pursuant to the share placement ("Placement") announced to ASX on 4 December 2020.

The Placement was completed pursuant to the Company's existing security issue capacity without shareholder approval, with 5,729,671 Shares issued pursuant to ASX Listing Rule 7.1 and 10,047,096 Shares issued pursuant to ASX Listing Rule 7.1A.

Please find attached an Appendix 2A and Cleansing Notice in respect of the issue of the Shares.

Share Purchase Plan ("SPP")

As advised on 4 December 2020, the Company intends to undertake a small SPP to allow existing eligible shareholders to subscribe for shares on the same terms as the Placement. The Company anticipates the distribution of SPP documentation to eligible shareholders to occur on 16 December 2020 and the SPP to close on 15 January 2021.
