# CLEANSING NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT 2001 (CTH)

Frugl Group Limited (**Frugl** or the **Company**) (**ASX: FGL**), has issued 37,250,000 fully paid ordinary shares as follows:
