

## FLTEM SURVEY TO COMMENCE AT NARNDEE Ni-Cu-PGE PROJECT


Aldoro Resources Limited (**Aldoro**, **the Company**) (ASX:**ARN**) is pleased to advise that High Power Fixed Loop EM (**FLTEM**) survey is scheduled to commence from early to mid January at the Company's 100% owned Narndee project (**Project**).

The FLTEM survey will enable a deeper understanding of the Project's highly prospective targets in preparation for the upcoming drilling campaign.

HPEM Geophysical Services has been engaged to conduct the survey and subsequent results will be reviewed by Southern Geoscience Consultants. Overall interpretation of data and drill target selections is expected to conclude in 4-6 weeks.

As announced on 24 November 2020, a total of sixteen major targets have been identified by the VTEM survey around the Milgoo Peak area of the Narndee Igneous Complex, consisting of 7 clear, discreet bedrock conductors and 9 broader, deeper anomalies. The final survey totalled 1,004 line km, mostly at 150m line spacing, and included 24 lines of infill over a number of the bedrock targets; along with extensional lines over three major anomalies highlighted on the eastern boundary of the survey area.

The Narndee Project continues to be Aldoro's core focus going forward and the Company shall provide shareholders with updates on exploration progress as required.
