Cleansing Notice

Lachlan Star Limited hereby notifies ASX under section 708A(5)(e) of the Corporations Act in relation to the issue of 82,500,000 consideration shares issued to the vendors of Coobaloo Minerals Pty Ltd (**Coobaloo**) following the acquisition of a 50% interest in Coobaloo, as announced 22 December 2020.

The Company has today issued 82,500,000 shares at a deemed issue price of \$0.005 per share, without disclosure, under Part 6D.2 of the Corporations Act. The Company, as at the date of this notice, has complied with:

- (a) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
- (b) section 674 of the Corporations Act.

As at the date of this notice, there is no information to be disclosed that is “excluded information” within the meaning of section 708A(7) and 708A (8) of the Corporations Act.

Accompanying this announcement is the Appendix 2A in respect of this issue.
