ANOTHER HIGH GRADE GOLD INTERCEPT 575 METRES NORTH OF FIRST HIT IN DEEPER DRILLING AT AARNIVALKEA

Key Points

- Assays received for the lower zone of the northernmost diamond hole (FAVD0064) recently drilled at the Aarnivalkea gold prospect, Finland
- Significant intercept of 20.4 metres @ 2.3g/t gold in hole FAVD0064, including 8.0 metres @ 4.8g/t gold, located 575 metres north along strike from previous high grade intercept of 6.85 metres @ 11.8g/t gold in FAVD0062, and 75 metres down dip of nearest hole on section
- These two holes are the only holes testing the depth potential beneath the main Aarnivalkea zone previously discovered in shallow reconnaissance drilling
- Nearest diamond drill lines to FAVD0064 are 320 metres north and 120 metres south, with the former including hole FAVD0030 with 3.0 metres @ 1.3 g/t gold from 47.9 metres followed by 3m of core loss in heavily weathered bedrock
- Planning underway to follow up these significant results

S2 Resources Ltd ("S2" or the "Company") advises that assays received from the lower portion of diamond hole FAVD0064 confirm a second high grade gold zone located 575 metres north of the high grade intercept hole FAVD0062 reported on 8th December 2020. This was the northernmost of four holes drilled in October 2020 to test for dip and plunge extensions to the gold mineralisation discovered in previous shallow reconnaissance drilling at the Company's 100% owned Aarnivalkea prospect in Finland.

Hole FAVD0064 returned a high grade gold intercept within a broader zone of mineralisation comprising:

 20.40 metres @ 2.3g/t gold from 193.1 metres, including 8.0 metres at 4.8g/t from 198.0 metres

This follows the previously reported high grade intercept in hole FAVD0062 (*refer to previous S2 ASX announcement on 8*th *December 2020*), located 575 metres to the south of FAVD0064, comprising:

• 6.85 metres @ 11.8g/t gold from 223.0 metres, including 4.0 metres @ 18.1g/t gold from 223.0 metres



Commenting on the drill results, S2's Chief Executive Officer Matthew Keane said "S2 has barely scratched the surface at Aarnivalkea after making a virgin gold discovery in 2019. The majority of holes to date have been drilled to less than 110 metres below surface on broad, 80 to 240 metre spaced section lines. The four deeper holes drilled in October 2020 were designed to test the depth potential of the "smoke" identified in this earlier shallow reconnaissance drilling. The fact that two of the four holes identified high grade gold, some 575 metres apart, is highly encouraging".

Aarnivalkea returns another high grade gold intercept at depth

In 2019, S2 discovered the mineralised gold trend at Aarnivalkea beneath shallow glacial cover in a previously unexplored area (*refer to previous S2 ASX announcement on 1 May 2019*). The discovery followed a systematic regional targeting approach comprising sequential ionic leach geochemistry, structural interpretation of geophysics, and base of till (BOT) drilling. Follow-up broad spaced shallow reconnaissance diamond drilling defined a broad zone of basement mineralisation over a +1,200 metre strike extent (*refer to previous S2 ASX announcement on 5 August 2019*).

In October 2020, the Company drilled four very widely spaced diamond holes to test for a range of possible down-dip and down-plunge extensions to the gold mineralisation defined in the earlier shallow drilling. Most assay results have now been received with all four holes intercepting gold mineralisation. One batch of samples from hole FAVD0063 are still awaiting assays. The latest results from hole FAVD0064 returned a high grade intercept within a broad zone of gold mineralisation. Better intercepts included:

- 1.8 metres at 0.9g.t gold from 160 metres downhole,
- 4.0 metres at 0.9g.t gold from 167 metres downhole,
- 20.40 metres at 2.3g/t gold from 193.1 metres downhole,
 - o including 8.0 metres at 4.8g/t from 198.0 metres downhole,
 - including 4.2 metres at 6.6g/t gold from 198 metres downhole

Hole FAVD0064 is located 575 metres north of the previously reported high grade intercept in hole FAVD0062 which included:

• 6.85 metres at 11.8g/t gold from 223.0 metres downhole, including 4.0m at 18.1g/t from 223.0 metres downhole

Mineralisation at Aarnivalkea remains open in all directions and there is no drilling below a depth of 120 metres between the intercepts in holes FAVD0062 and FAVD0064. The nearest shallow drill lines adjacent to FAVD0064 are located 120 metres south and 320 metres north.

Importantly, FAVD0030, a shallow diamond hole located on the northernmost section line (7,552,720mN), intersected 3.0 metres @ 1.3 g/t gold from 47.9 metres within strongly oxidised bedrock with 3 metres of core loss immediately after. This intercept may reflect the presence of a deeply weathered and potentially leached sulphidic zone situated on the near surface strike projection of the new intercept in hole FAVD0064.



While S2's understanding of the controls on mineralisation is in its infancy, the scale of this system (+1,200 metres total strike) and its propensity to generate high grade mineralisation is highly encouraging and warrants further drilling.




Figure 1. Aarnivalkea prospect location map showing S2's landholding in Lapland, Finland, including neighbouring companies, mines, defined resources and recent drill intercepts. Resources and drill intercepts are sourced from public company statements.

Aarnivalkea is located only 24 kilometres from Agnico Eagle's (AEM.TSX) Kittilä mine, the largest producing gold mine in Europe. The Central Lapland Greenstone Belt (CLGB) remains underexplored and highly prospective, as highlighted by both S2's and Rupert Resources' (RUP.V) recent successes. S2's substantial 595 square kilometre land holding in the CLGB (Figure 1) is strategically positioned proximal to major structures prospective for both orogenic/mesothermal gold and magmatic intrusive base metal mineralisation.




Figure 2. Plan projection of drilling at Aarnivalkea, showing the location of recent diamond drillholes (blue), key section lines and the northwest striking BOT gold mineralised zone (yellow shading), including higher grade lenses (red and magenta shading).






Figure 3. Isometric view showing drilling to date at Aarnivalkea, highlighting the lack of deeper drilling between, below, and north of holes FAVD0062 and FAVD0064.




Figure 4. Cross section through section line 7,552,400mN showing drill hole FAVD0064.






Figure 5. Cross section through section line 7,551,840mN showing drill hole FAVD0062.



Mineralisation in hole FAVD0064 is hosted within fine to medium grained intermediate dacite-andesite volcanics with interfingered porphyritic rhyodacite. The interval has varying levels of albite-sericite alteration and contains numerous thin quartz-carbonate-pyrite veinlets with pronounced sericite alteration halos. Disseminated pyrite is evident throughout the interval (Figure 6).

Next steps for Finland Exploration

At Aarnivalkea, S2 is undertaking a detailed geochemical and structural study of the mineralised system to gain a better understanding of the key controls on high grade mineralisation to optimise follow-up drilling to test along strike and down-dip of the recent intersections. The timing of this drilling will be dependent on diamond rig availability, which is currently constrained due to heightened exploration interest in the CLGB and peak seasonal demand (drilling is most active in the winter months due to ground freezing). Importantly, large portions of Aarnivalkea can be drilled all year round, including the zone between holes FAVD0062 and FAVD0064.

At the Palvanen exploration licence, located to the south of Aarnivalkea and adjacent to Agnico Eagle's Kittilä gold mine, regional BOT drilling is planned across prospective stratigraphic / structural corridors to identify areas for follow-up infill BOT and diamond drill testing.

The Company is also anticipating the grant of licences on the Ruopas area in the first half of 2021. Ruopas is prospective for magmatic intrusive style nickel-copper-PGE mineralisation, being located 85 kilometres west of Anglo American's (AAL.LSE) 44.4Mt Sakatti copper-nickel-PGE deposit and 95 kilometres west Boliden's (BOL.STO) 297.5Mt Kevitsa nickel-copper and precious metal mine (Figure 1). Activities planned for 2021 (pending the grant of exploration licences) include diamond drilling of the Ruopas 1 conductor (refer to previous S2 ASX announcement on 16 May 2019), and ground electromagnetic surveying and BOT drilling of recently identified base metal targets elsewhere on the Ruopas licence.
