Cleansing Notice / Appendix 2A

European Metals Holdings Limited (“**European Metals**” or “**the Company**”) (ASX & AIM: EMH, NASDAQ: ERPNF) advises that it has completed the issue of 1,463,734 CDIs in respect of the full drawdown of the Fund Facility Agreement between 6466 Investments Pty Ltd and European Metals.
