## Payment to the Mishkeegogamang First Nations and Cleansing Statement

Ardiden Limited (ABN 82 110 884 252) (ASX: ADV) (**Company**) advises that it has today issued 10,000,000 fully paid ordinary shares to Mishkeegogamang First Nations in respect of the payment of the Binding Exploration Memorandum of Understanding previously announced on 21 April 2020 over the Kasagiminnis Gold Prospect. The issue of these shares was approved by shareholders at the 2020 AGM.
