1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No the entity does not expect to have the current level of net operating cash flows. Capitalised exploration & evaluation fees were above normal this quarter due to the payment of the annual licence fees (\$96k), and Central Land Council annual fees and site clearance fees(\$68K) . Additionally, due to capital raising activities and the acquisition of Goshawk, share registry costs were higher than average, and the ASX fees for the issue of the acquisition shares were incurred.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The entity has successfully placed 100 million shares during January 2021 to raise 1.1 million dollars before costs.

Answer: Yes due to the successful placement that occurred in January 2021
