Cleansing Notice - NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS Act

Adriatic Metals PLC (ASX:ADT, LON:ADT1) ("Adriatic" or "the Company"), confirms that on 29 January 2021 it completed the issue and allotment of 241,202 new Ordinary Shares in the form of Chess Depository Interests ("CDIs"). The CDIs were issued pursuant to the strategic alliance agreement between the Company and Sandfire Resources Limited.

The Company gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act) that:

1. the Company issued the CDIs without disclosure under Part 6D.2 of the Corporations Act; and
2. as at the date of this notice, the Company has complied with:
