Audalia Resources Limited (ASX: **ACP**) is pleased to present its report for the December 2020 quarter.

MEDCALF PROJECT

The Medcalf Project is a vanadium-titanium-iron project located some 470 kilometres south east of Perth near Lake Johnston, Western Australia. The Medcalf Project comprises three granted Exploration Licences E63/1133, E63/1134 and E63/1855 as well as mining lease M63/656 and miscellaneous licence L63/75. Together, these licences cover a total area of 38 km².

The Medcalf Project lies in the southern end of the Archaean Lake Johnston greenstone belt. This greenstone belt is a narrow, north-northwest trending belt approximately 110 km in length. It is located near the south margin of the Yilgarn Craton, midway between the southern ends of the Norseman-Wiluna and the Forrestania-Southern Cross greenstone belts.

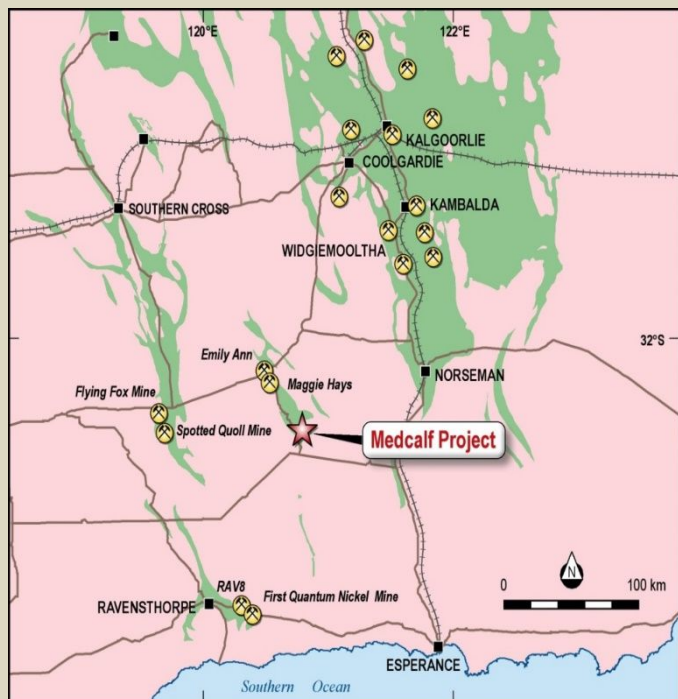


Figure 1: Medcalf Project - Location Map

Environmental Approval

During the quarter, comments on draft Environmental Review Document (**ERD**) were received from WA Environmental Protection Authority (**EPA**) and other government agencies. Audalia has completed additional environmental studies to address the comments. Audalia submitted the revised ERD document during the quarter and pending EPA's acceptance for public review.

Field work

During the quarter, 89 drillholes from the 2018 drilling program were rehabilitated. A number of these drillholes were used for several troglofauna surveys that were completed by Bennelongia as part of the environmental studies.

CORPORATE MATTERS

The Company had cash and cash equivalents as at 31 December 2020 of \$479,000 (Q1: \$97,000) following payments for capitalised exploration and evaluation expenditure of \$299,000 (Q1: \$311,000) and payments to related parties and their associates of \$132,000 (Q1: \$114,000) during the December 2020 quarter.

Capital raising

In November 2020, the Company raised \$400,000 before costs by way of a placement of 20,000,000 fully paid ordinary shares in the Company at an issue price of \$0.02 per share to a sophisticated investor.

The funds raised will be used to progress the exploration and evaluation work at the Company's Medcalf Project and supplement general working capital.

The Company acknowledges its cash position at the end of the quarter and its estimated cash available for future operating activities. The Directors continue to assess funding alternatives to ensure the Company can continue exploration and evaluation activities at the Medcalf Project.
