Answer: Yes.

SportsHero has taken proactive steps to reduce normalised operating costs. We expect net cash used in operating activities to decrease to around \$450,000 in Q3FY21.

In addition, following the resumption of international football, SportsHero expects revenue generation to commence in FY2020/21.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Yes. On 10 September 2020, SportsHero announced the execution of a definitive Standby Placement Agreement with Mint Capital Advisors to provide up to \$5 million in equity funding over a 3 year term (Facility). In accordance with the terms and conditions of the Facility, the Company (at its sole discretion) can elect to make a drawdown under the Facility. The maximum drawdown amount being \$140,000 per month. On 20 October 2020, the Company completed a \$68,933 drawdown at an issue price of \$0.02223 per share.

On 22 January 2021, \$450,000 was raised pursuant to the issue of 18,000,000 fully paid shares at an issue price of \$0.025 per share.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes: Following the recommencement of football matches and fixtures, SportsHero expects to continue its operations and to meet its business objectives for the following reasons:

- a full and functioning range of products are now launched, with Olahbola generating in excess of 1.8 million new unique users since its launch in July 2020:
- exclusive partnerships are in place with two of the world's largest sporting leagues; and
- the SportsHero products have been expanded to enhance the experience of fans across multiple sporting events and media platforms.
