Answer: The entity constantly reviews its cash flow position. As a result of the divestment of the Ben Hur Project as announced on 2 September 2020 and after completion of the DECA as announced on 18 November 2020, the entity holds highly liquid Regis Resources Limited (ASX: RRL) freely tradeable shares with an estimated market value of approximately \$2.2 million. The entity is able to dispose of these shares to provide adequate funding to support its operations as and when deemed appropriate.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: The entity has successfully completed its recapitalisation in November 2020 and has commenced developing its renewed exploration and development strategy. Combined with the answer to Question 2 above, the entity does expect to be able to continue its operations and meet its business objectives.
