

## **CLEANSING NOTICE**

**PERTH, AUSTRALIA; 5 FEBRUARY 2021**: Hazer Group (ASX: HZR) (Hazer or the Company) provides the following information in relation to the shares issued today being:

i. 200,000 new fully paid ordinary shares (Shares) pursuant to the exercise of 200,000 unlisted Series K options with a \$1.20 exercise price and 31 December 2021 expiry date, raising \$240,000.

Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Act")

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the Shares noted above and in the Appendix 2A announced on 13 October 2020 will fall within the exemption in section 708A(5) of the Act.

- 4 as at the date of this notice, there is no information to be disclosed under section 708(6)(e) of the Act which is excluded information (as defined in sections 708A(7) and 708A(8) of the Act).
