Cleansing Notice / Appendix 2A

European Metals Holdings Limited (“**European Metals**” or “**the Company**”) (ASX & AIM: EMH, NASDAQ: ERPNF) advises that it has completed the issue of 6,454,546 CDIs to institutional and sophisticated investors announced on 3 February 2021 at \$1.10 per CDI to raise \$7.1 million. The CDIs have been issued utilising existing Listing Rule 7.1 capacity.
