

Completion of Tranche 1 Placement

On 9 February 2021, Talon Petroleum Ltd (ASX:TPD) (**Company**) completed the issue of 1,000,000,000 Tranche 1 Placement Shares as set out in the Company's Appendix 3B dated 3 February 2021. Funds from Tranche 1 Placement totalling A\$4 million have been received to the Company's bank account. The Company utilised its 7.1 and 7.1a placement capacity for the issue.

As announced 3 February 2021, TPD secured firm commitments from new and existing institutional and sophisticated investors to raise a minimum A\$4 million, with the ability to accept a further A\$1m in oversubscriptions through the issue of a maximum 1.25 billion New Shares. The Placement was strongly supported with A\$5m raised. New Shares were issued at a price of A\$0.004 each. Tranche 2 Placement Shares are subject to shareholder approval at the Company's General Meeting to be held late March 2021.
