



SECTION 708A NOTICE - SHARE ISSUE

Alice Queen Limited (ASX:AQX) (Company) is pleased to announce the allotment and issue on 10 February 2021 of 5,000,000 fully paid ordinary shares Issue to a consultant for consultancy and advisory services provided to the Company in connection with identification, and securing rights to, projects in New South Wales. The issue of these shares was approved by shareholders at the 2020 AGM on 16 November 2020.

Secondary Trading Exemption
