



Copper Exploration Efforts Progressed With Early Exercise of Unlisted Options Raising \$1.3m

Eagle Mountain Mining Limited (ASX:EM2) ("Eagle Mountain", the "Company") is pleased to advise that it has received a total of \$1.3m from the exercise of unlisted options by Directors and their associates, and other parties.

Managing Director and major shareholder, Charles Bass, commented:

"This funding allows us to take advantage of the current tight labour market and attract additional top calibre personnel that will substantially augment Eagle Mountain's teams both in Arizona and Perth. As we are encouraged by results to-date from the Oracle Ridge copper-silver-gold project, our intention is to progress the exploration efforts with the aim of establishing a substantial resource base. This funding will also take us through the \$US5 million sole funding requirement for Oracle Ridge, an 80:20 joint venture. Once that expenditure has been met, the 20% partner will have a once-off decision point to either dilute their interest by not contributing to further exploration or share in those costs. Either way, it will be a plus for Eagle Mountain."

The Company has received valid exercise notices and received payments totalling \$791,482 from the early conversion of 3,957,411 unlisted options which were due to expire on 31 July 2021 with a strike price of 20 cents. All Directors and associates early exercised their options contributing \$769,482.

Additionally, the Company has received valid exercise notices and payment totalling \$536,250 from third parties for the conversion of 1,787,500 unlisted options at a strike price of 30 cents which were due to expire on 6 March 2021.

The Company is grateful to its Shareholders and Directors for their ongoing financial support and belief in Eagle Mountain. The additional funds will support our ongoing exploration activities at the high-grade Oracle Ridge copper project, along with expanding our geology teams both in Perth and Tucson. In addition to the ongoing diamond drilling program, field teams are close to finishing detailed mapping of various near mine exploration targets and establishment of drill sites will be completed in the coming weeks.
