This notice is given by Argosy Minerals Limited (ACN 073 391 189) ("**Argosy**" or "**Company**") (ASX:AGY) pursuant to section 708A(5)e of the Corporations Action 2001 (Cth) (**Corporations Act**)

On 16 February 2021, the Company issued 230,769,230 fully paid ordinary shares upon completion of a placement to institutional and sophisticated investors at the issue price of \$0.13.
