- **ODA, through its wholly-owned subsidiary, have partnered with Dickerson Digital to become a certified 'Supply Nation' provider.**
- **Dickerson Digital's team of software developers are working with ODA on a smart light pole project for roads, rail & air.**
- **Supply Nation is a non-profit organisation that aims to grow the Aboriginal and Torres Strait Islander business sector through the promotion of supplier diversity in Australia.**
- **Partnership is aimed to carry out contract work on multiple projects as an indigenous controlled entity.**

Orcoda will retain its 49% shareholding through its 100% ownership of Orcoda Resource Logistics.

Dickerson Digital has expertise in artificial intelligence (AI), machine learning (ML), augmented reality (AR), virtual reality (VR) cyber security, ICT Services and, internet of things (IOT). DD has a team of software developers and has been working with Orcoda on a smart light pole technology project for roads, rail & air.

The intention is for RC to become a certified Supply Nation provider to enable RC to carry out contract work on multiple projects as an indigenous controlled entity.

Supply Nation is working to connect over 2,800 verified Indigenous businesses on Indigenous Business Direct with more than 450 paid corporate, government and not-for-profit members across every state and territory. Supplier diversity is a growing movement in Australia and we are grateful to be part of creating a more inclusive economy and help Federal Government, State Governments and Local Government Authorities to meet its target of awarding 3% - 5% of all Government contracts to indigenous controlled organisations.

The Australian Government department of infrastructure, transport, regional development and communications is investing \$110 billion over 10 years from 2020-21 in transport infrastructure across Australia through its rolling infrastructure plan, of which a substantial component is under the Infrastructure Investment Program\*. The department is working with every Australian State and Territory to build much-needed infrastructure across a number of individual funding programs.
