Cleansing Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth)

Global Oil & Gas Limited (ASX:GLV) ("the Company") has issued 10,000,000 ordinary fully paid shares ("Shares") as a result of the conversion of 10 million Class A Performance Rights.
