ADDITIONAL \$3.95M RAISED THROUGH EXERCISE OF OPTIONS

Beacon Minerals Limited (ASX: **BCN**) (“**Beacon**” or “**the Company**”) wishes to advise that a total of \$11.495 million has now been raised through the exercise of the Company’s Listed Options (ASX: BCNOB).

Since the Company announced its unfranked dividend a total of 459,799,236 Listed Options have been exercised. At the date of this release there are 438,067,584 Listed Options that remain on issue.

Shareholders are reminded that the early conversion of the Listed Options will ensure that the options are converted in time to be eligible for the \$0.007 dividend.

The Directors have now exercised all of their 160,194,331 Listed Options, for a total of over \$4.0 million.
