### A FURTHER \$2.18M RAISED THROUGH EXERCISE OF OPTIONS

Beacon Minerals Limited (ASX: **BCN**) (“**Beacon**” or “**the Company**”) wishes to advise that a total of \$13.676 million has now been raised through the exercise of the Company’s Listed Options (ASX: BCNOB).

Since the Company announced its unfranked dividend a total of 527,049,339 Listed Options have been exercised. At the date of this release there are 370,817,481 Listed Options that remain on issue.
