## **Alltype Engineering Awarded \$10M in New Contracts and Contract Extensions Across Broad Industry Client Base, Whilst Delivering Against Key Contract Timeframes**

### **Highlights**

- **WestStar subsidiary Alltype Engineering has been awarded ~\$10M of contracts and contract extensions across the oil and gas, energy, mining, water infrastructure and petrochemical industry with highlights on new awards as follows:**
  - **Australian Gas Infrastructure Group (AGIG) – FRGP Solomon Metering Station Upgrade**
  - **Contract Power – Power Station Radiator Piping Infrastructure**
  - **SIMPEC – Pilbara Minerals Ltd – Pilgangoora Tantalum Lithium Project – Fabricated Rubber Lined Carbon Steel Piping Package**
- **In addition to the issue of further contract scope on existing projects, Alltype Engineering has achieved key practical completion on the following projects:**
  - **APA Group – Lakeway SO4 Potash Gas Lateral Offtake and Metering Project**
  - **APA Group – Karlawinda Gas Lateral Offtake and Metering Project**
  - **McConnell Dowell – Murrin Loop Gas Lateral End of Line Facilities**

**WestStar Industrial Limited (Company or WestStar)** (ASX: WSI), an Australian industrial services company providing engineering, construction and mining services to the resources, energy and infrastructure sectors; is pleased to advise its engineering construction contracting business Alltype Engineering (**Alltype**) has been awarded contracts to a total value of ~\$10M across multiple clients and projects. This includes \$5M of new and expanded contracts in mining infrastructure, with the balance awarded from its existing diverse client base.

The Contracts further bolster and contribute to the WestStar FY2021 contracted order book.

### **Australian Gas Infrastructure Group (AGIG) – FRGP Solomon Metering Station Upgrade**

Alltype has been engaged by AGIG on the upgrade of its Solomon metering station located approximately 280km south east of Karratha.

The outcome of the Project will increase the metering capacity at the AGIG Solomon Meter Station from 26TJ/d to 64TJ/d. New filtration, metering and pressure control equipment will be installed within the existing facility to supply gas through a second metered connection to a new Fortescue power station at its iron ore mine at Solomon.

In addition to the new connection, the existing metering equipment will be upgraded to increase the metering capacity to the existing power station. A new primary water bath heater will be installed to deliver the required heat input to the gas supplied to both connections.

Alltype scope of works includes fabrication, assembly and installation of new process piping and a control skid, fabrication and installation of off-skid pipe and supports, installation of a new water bath heater, fit out and installation of a new Control Hut and Carry out brownfield civil, SMP, electrical and instrumentation works. Alltype has commenced the works with delivery expected in FY21.

## Contract Power - Power Station Radiator Piping

Alltype has been awarded a contract to supply, fabricate and pre-assemble radiator piping by Contract Power Australia. The package has commenced and will be delivered by August 2021. Alltype will be procuring materials, managing processing and surface treatment of the piping, fabricating the support steelwork and modularising the pipe racks to transportable dimensions for efficient installation on site.

## SIMPEC Ironmerge JV – Pilbara Minerals Ltd – Pilgangoora Tantalum Lithium Project – Rubber Lined and Carbon Steel Piping Package

Alltype has been awarded a contract through the SIMPEC Ironmerge JV for supply and fabrication of Rubber Lined, Polyurethane Lined and Carbon Steel spooling for the Pilbara Mineral Ltd Pilgangoora Stage 1 project. Works are valued close to \$1M and demonstrate the synergies that can be gained between the merger of SIMPEC and Alltype Engineering under the WestStar Group. Works are to be staged by priority with the final delivery scheduled for July 2021.

## Other works

In addition to the above, Alltype continues to build the pipeline of new work opportunities, with works being tendered and developed increasing in both value and complexity as well as geographical location. The engagement with existing and new customers on these works is a reflection of Alltype's expanded offerings and reputation for reliably delivering projects with a significant control over the project supply chain lifecycle.

Alltype Managing Director Kelvin Andrijich noted:

*"By delivering on our project commitments to our clients, Alltype Engineering continues to build a reputation and market awareness around our capability to safely and reliably deliver multidiscipline projects involving both workshop fabrication and site construction scopes. We have expanded our portfolio of MOU's and JV agreements with industry leading partners locally, nationally and internationally, increasing our capabilities and offerings. We are proud that during the current pandemic our interstate and overseas clients can rely on our company to assist them in delivering on their commitments and look forward to future opportunities that these partnerships can bring. Our expansion plans are back on track with an increasing number of opportunities for site construction works being tendered in the eastern states, with turnkey project bids having been submitted or prepared for works in Queensland, New South Wales, Victoria and South Australia. We have a solid team and organisation and look forward to the improving market conditions in 2021."*

## Outlook

WestStar Industrial; through its subsidiaries Alltype and SIMPEC, is well positioned for FY2021 having now secured ~\$70M of new contract awards this financial year.

Tendering and proposals across the group remains strong, with over \$400M of new tenders received and being worked on. Several of the submissions were for new clients within the mining and infrastructure, energy sectors. The results of increased activity and tendering is now delivering positive outcomes for the business.

We look forward to updating the market as these opportunities become successful.
