BNYMC Group's power to vote or dispose of these securities is qualified accordingly.

\*Note 2: Each Group Entity is a direct or indirect wholly owned subsidiary of BNYMC, the ultimate parent company. Other than BNYM in respect of 862,430,300 securities (of which BNYM's power to only dispose of 862,430,300 securities is limited – see Note 1), and BNY Mellon, National Association in respect of 307,500 securities, none of the BNYMC Group entities are entitled to be registered as holder of the securities and their power to vote or dispose of the securities is qualified accordingly.
