

Completion of \$5m Placement

On 3 February 2021, Talon Petroleum Ltd (ASX:TPD) (**Company**) secured firm commitments from new and existing institutional and sophisticated investors to raise a minimum A\$4 million, with the ability to accept a further A\$1m in oversubscriptions through the issue of a maximum 1.25 billion New Shares. The Placement was strongly supported with A\$5m raised. Chieftain Securities (WA) Pty Ltd acted as Lead Manager to the Placement.

New Shares were issued at a price of A\$0.004 each. Tranche 1 completed on 9 February 2021 and utilised the Company's 7.1 and 7.1a Placement Capacity.

On 26 March 2021, the Company held a General Meeting for the approval of the issue of Tranche 2 Placement Shares, Consultancy and Consideration Shares and Broker, Advisor and Director Options. All resolutions were passed by way of poll.
