Delorean Corporation Limited (ASX: DEL) – Admission and Commencement of Official Quotation

Description

Delorean Corporation Limited ('DEL') was admitted to the Official List of ASX Limited ('ASX') today, Thursday, 8 April 2021.

DEL raised A\$14,000,000 pursuant to the offer under its prospectus dated 4 March 2021 ('Prospectus') by the issue of 70,000,000 shares at an issue price of A\$0.20 per share.

A further 525,000 shares were issued to eligible employees pursuant to the Incentive Share Plan.

DEL also issued 4,267,566 fully paid ordinary shares to RM Corporate Finance Pty Ltd as consideration for underwriting and lead management services provided to DEL (the 'Advisor Offer').
