Completion of \$8,250,000 Placement

Pursuit Minerals Limited (ASX:PUR) ("Pursuit" or the "Company") is pleased to confirm that it has completed the placement of 119,565,217 fully paid ordinary shares (**Placement Shares**) to the clients of CPS Capital (**Placement**) as announced on 1 April 2021. The Placement Shares were issued with an issue price of \$0.069 per Placement Share, raising \$8,250,000 (before costs).

In addition, the Company has issued 20,000,000 options (PUROA, quoted on ASX) to CPS Capital, which are to be distributed to the brokers that assisted with the Placement (**Broker Options**). CPS Capital has also been paid a cash fee equal to 6% of the amount raised under the Placement.

The Company hereby further confirms:

- S3 Consortium Pty Ltd (Stocks Digital) has been issued 3,000,000 Shares for nil cash consideration, topping up Stocks Digital's marketing services with an additional \$207,000 worth of services at a deemed issue price of \$A0.069 per Share (**Marketing Shares**).
- issued 100,000 ordinary fully paid shares following the issue of 100,000 PUROA listed options which has raised \$1,000.

The Shares under the Placement were issued in a single tranche using the Company's existing placement capacity with; 43,681,768 Shares to be issued under PUR's LR 7.1 placement capacity; and 78,057,362 shares to be issued under PUR's LR 7.1A placement capacity. The options to be issued to CPS Capital and the Shares to be issued to Stocks Digital will also be issued under the Company's LR 7.1. placement capacity.

Further details relating to the issue of the Placement Shares are set out in the Appendix 3B that the Company released on 31 March 2021 and the Appendix 2A as attached.
