

NOTICE UNDER SECTION 708A(5) OF THE CORPORATIONS ACT 2001

This notice is given by Auroch Minerals Limited (**Auroch** or the **Company**) in relation to the issue of 940,910 fully paid ordinary shares on 12 April 2021 upon the conversion of 940,910 unlisted options exercisable at \$0.10 each on or before 30 November 2021 as detailed in the attached Appendix 2A.

The Corporations Act 2001 (Cth) (**Act**) restricts the on-sale of securities issued without disclosure unless the sale is exempt under section 708 or 708A of the Act.
