# Health House International signs distribution agreement with Dragonfly Biosciences

- Distribution Agreement signed with UK based Dragonfly Biosciences
- Agreement strengthens Health House's product portfolio within Australia
- Initial Agreement to provide Dragonfly products for two years

Health House International Limited (ASX:HHI) (Health House or the Company) is pleased to announce it has signed a non-exclusive distribution agreement (Distribution Agreement) with Dragonfly Biosciences Limited (Dragonfly), a United Kingdom (UK) makers of a leading, UK award winning, seed to shelf range of CBD oils and skincare products.

The Distribution Agreement, with an initial term of two years with an additional renewal term of a further two years, will further expand Health House's product portfolio for medicinal cannabis within Australia.

Up until March 2021 the Australian Therapeutic Goods Administration has approved over 100,000 patient applications for medicinal cannabis. We expect this market to grow considerably.
