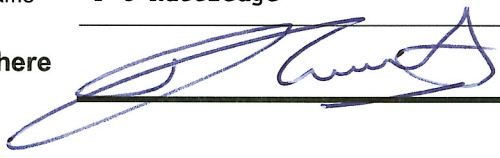

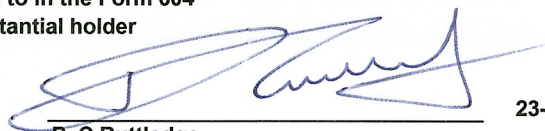
DIRECTIONS
