GROWTH STRATEGY

The Australian security industry is highly fragmented and Threat Protect believes is conducive to consolidation, given its stable revenue streams and fixed infrastructure cost model.

Threat Protect's growth strategy is focused on leveraging the largely fixed cost infrastructure and significant capacity of its existing extensive security control room through acquisition of monitored security client bases across Australia.

Threat Protect Australia Limited ("**Threat Protect**" or "**Company**") (ASX:" **TPS**") is pleased to provide its quarterly market activity update.

HIGHLIGHTS FOR THE QUARTER

- Operating revenue of \$6.4m was in line with the prior quarter.
- Positive operating cashflow continued in the current quarter. Operating cashflow for the quarter was \$1.5m before acquisition and integration cash outflows of \$321,000 and interest and other costs of finance of \$665,000. Net cash from operations was \$465,000.
- Receipts from customers of \$6.6m was lower than the prior quarter (\$761,000) due to the reduction in Accounts Receivable associated with the funding mechanism of an acquisition and less favourable invoicing timing in the current quarter.
- Gross margin at \$2.6m was in line with the prior quarter \$2.7m.
- Adjusted EBITDA before acquisition and integration costs declined by \$241,000 to \$1.3m for the quarter due to a reduction in maintenance gross margin and SG&A one offs.
- Integration costs of \$219,000 are in line with the prior quarter and include excess capacity costs in anticipation of the consolidation of control room capacity.
- The Company has \$2,042,000 of cash on hand at 31 March 2021.

Operating Revenue

Group revenue was in line with last quarter at \$6.4m.

In item 6 of the Appendix 4C cash flow report for the quarter, payments to Related Parties of approximately \$110,000 comprised of fees to executive and non-executive directors and their related parties' remuneration, including \$25,000 of fees paid to Black Crane Asia Opportunities Fund for corporate advisory services.

Cash at Bank & Summary of Cash Flows

Cash at bank at the end of March 2021 was \$2.0m, compared with \$2.4m at 31 December 2020. Net cashflow from operating activities was \$465,000, down \$900,000 from \$1.4m for the previous quarter and is comprised of the following:

The main variances include a decrease in receipts from customers by \$761,000, and an increase in payments for operating costs of \$107,000 compared to the prior quarter.

Net cash used in investing activities was up \$596,000 to \$939,000 due to the payment for acquisition of lines and contingent consideration. Net cash flows from financing activities were down \$2.2m from \$2.1m for the previous quarter due to the borrowings repayment made to Soliton Capital Partners Pty Ltd in the prior quarter, and premium funding raised.
