The position follows on from the Corporations Act 2001 (Cth) under the Corporations (Coronavirus Economic Response) Determination (No. 3) 2020 which expired on 21 March 2021. ASIC's "no action" policy facilitates electronic dispatch of notices of meeting. Accordingly, the Company will not be dispatching hard copies of the Notice of Meeting to shareholders.
