Issue of unlisted options

Prodigy Gold NL (ASX: PRX) ("Prodigy Gold" or the "Company") advises that it issued 200,000 unlisted options with a zero exercise price under the Company's Employee Share Option Plan. The options are issued as part of an initiative to encourage long-term staff retention. Vesting of these option is dependent on continuity of employment to 1 July 2023. Further details are included in the attached Appendix 3G.

Cancellation of unlisted options

The Company advises that a total of 1.7 Million unlisted options have expired and lapsed unexercised on 3 May 2021.

The exercise conditions of the options were as follows:
