

Issue of First Milestone Shares

HSC Technology Group Ltd (ASX: HSC) (Company) wishes to advise that the vesting criteria for the First Milestone Shares which make up part of the deferred consideration payable to the Homestay Shareholders under the Acquisition announced 10 May 2018, has been satisfied.

As approved by Shareholders at the meeting held 23 August 2018, 50,000,000 million ordinary shares are to be paid to the shareholders of HomeStay Care Pty Ltd upon the Company generating cumulative revenue of \$3,000,000 on or before 19 November 2021 and such revenue being independently confirmed by the Company's auditors.

The satisfaction of this vesting criteria has been independently verified by the Company's Auditors, the details of which are contained in the Company's 2021 Annual Report. The Company is now seeking the quotation of the 50,000,00 ordinary shares.
