Health House International commences delivery for Levin Health

- Health House has executed Levin Health's first deliveries of medicinal cannabis in Australia.
- Levin Health recently launched its first Levin medicinal cannabis product and completed its first sale in late April.
- Health House is Levin Health's exclusive Distributor in the Australian market.

Health House International Limited (**ASX:HHI**) (**Health House** or **the Company**) are pleased to announce it has commenced delivery for new medicinal cannabis supplier Levin Health Limited (**Levin Health**) under its existing exclusive distribution agreement (**Distribution Agreement**).

Levin Health Chairman, Matt Syme, acknowledged the importance of the inaugural sales as a key milestone for Levin and thanked Health House for their important role in developing Levin Health's business:

"We are very pleased to hear confirmation Health House has shipped our Levin Health products following the Levin Health's first sales. Levin is a medical research and marketing company, and we are happy to have reliable and trusted partners like Health House to fulfill our supply chain requirements. We are looking forward to building up our Australian business with Health House, before launching overseas later this year."

Health House Chief Operating Officer - Australasia, Paul Mavor said *"Levin Health's medicinal cannabis brand targets pain patients in sports men and women. Around 70 to 80 percent of Australian patients using medicinal cannabis are doing so for relief from chronic painⁱ. This is a substantial market, with an estimated 1 in 5 Australians living with chronic painⁱⁱ including many from sporting related injuries."*

- The commencement date of the Distribution Agreement is 24 February 2021, with an initial term of two years with an additional renewal term of a further two years
- The Company cannot, at this stage, fully quantify the impact of the contract will have on the price of its securities.
- As is usual in agreements, the Agreement is terminable mutually or when one party fails to perform by either party giving 90 days written notice.
- There are no conditions precedent that remain unsatisfied.
- The Company notes that Health House's Chairman Mr David Wheeler is non-executive director and a shareholder in Levin Health Ltd holding approximately 0.45%. Mr David

Wheeler was excluded from any discussions in relation to the Distribution Agreement with Levin Health.
