COMPLETION OF NON-RENOUNCEABLE RIGHTS ISSUE

Great Northern Minerals Limited (“**Great Northern Minerals**” or the “**Company**”) (**ASX: GNM**) is pleased to advise that it has completed the issue of all entitlement securities offered under the Non-Renounceable Rights Issue Offer (“**Rights Issue Offer**”) announced to the market via a prospectus dated 26 March 2021 (“**Prospectus**”). The Company has also completed the issue of the shortfall securities with the remaining securities being issued to CPS Capital Group Pty Ltd as the underwriter of the Rights Issue Offer (**Underwriter**).

The Company has issued a total of 151,131,372 New Shares at an issue price of \$0.01 per New Share to raise up to \$1,511,314 (before expenses), together with 151,131,372 free attaching Listed GNMOB Options (exercisable at \$0.022 and expiring on 1 July 2023) comprising of the securities set out below:

As previously announced, and as set out in the Prospectus, the Underwriter and Directors reserved the right at their absolute discretion, subject to the Corporations Act and Listing Rules, to place the Shortfall Securities.

As part of the Underwriting Agreement, the Company will pay to the Underwriter a management fee of \$10,000 cash (plus GST) and an underwriting fee of 4% (plus GST) of the underwritten amount. Further details regarding the terms of the Underwriting Agreement are set out in the Prospectus.

An Appendix 2A relating to the issue of securities accompanies this announcement.

The Directors thank all shareholders and CPS for their participation in this capital raising which will facilitate the rapid advancement of the Company’s North Queensland gold properties .

The Company's key North Queensland Gold Projects include the Golden Cup, Camel Creek and Big Rush Gold Mines in North Queensland.
