High-Grade Gold Zone Developing at Bulgera 16m @ 7g/t Au (inc. 3m @ 30 g/t Au)

Highlights:

- Final gold assay results received for March 2021 reverse circulation (RC) drilling below historical open-cut deposits at Bulgera Gold Project (NWM 100%)
- New high-grade gold intersections reporting as:
 - 16m @ 7.3g/t Au (inc. 3m @ 30.3g/t Au) from 194m in BRC21015 with hole finishing in 18.5g/t gold mineralisation at 210m
 - o 6m @ 11.8g/t Au (inc. 3m @ 22.4g/t Au) from 218m in BRC21013
- Latest results occur along strike and down dip from high-grade discovery hole BRC21001 (5m @ 15g/t Au from 194m)
- Drillhole planning underway to test down-dip potential

Norwest Minerals Limited ("Norwest" or "the Company") (ASX: NWM) is pleased to announce that all gold assay results have been received from its 26-hole x 5,000m RC drilling programme that was completed in March 2021 and which was designed to test for high-grade gold mineralisation extending below the historical Bulgera and Mercuri open pits.




Figure 1 – Long section with RC gold intersections defining the wide, very high-grade gold lode developing below the historical Bulgera open cut.

Approximately 120 metres beneath the historical Bulgera open-cut, holes **BRC21013 & BRC21015** intersected wide, high-grade gold mineralisation returning **6m @ 11.8g/t gold (inc. 3m @ 22.4g/t Au) from 218m** and **16m @ 7.3g/t gold (inc. 3m @ 30.3g/t Au) from 194m** respectively, with BRC21015 ending in very high-grade gold mineralisation of 18.5g/t Au at 210m. These high-grade intersections occur along strike and down dip from the high-grade gold intersected in discovery hole **BRC21001 (5m @ 15g/t gold from 194m)** announced February 2021¹. (See Long Section – Figure 1).

Norwest's CEO, Mr. Charles Schaus commented: "We are excited with these assay results from our March 2021 drilling programme. The continuity of these relatively shallow, wide, high-grade drill intersections demonstrates Bulgera's significant potential, especially with one of the holes ending in very-high grade mineralisation at only 210 metres. We are very keen to recommence drilling to test for down dip extensions of this gold-rich zone."

Deep RC Drilling Programme

Norwest commenced a 5,000m RC drilling programme at its 100% owned Bulgera Gold Project late last year. The aim was to determine if gold mineralisation below the historical Bulgera and Mercuri gold deposits continued at depth accompanied by an increase in gold tenor. Last year, a Company review of gold deposits and prospect located along the Marymia Mine sequence showed that widths and gold grades of drill intercepts appeared to increase below 100 vertical metres.

RC Drilling below the Bulgera open pit

In mid-February 2021, Norwest announced hole **BRC21001 had intersected 5m @ 15g/t gold from 194m** being ~170 vertical metres from surface. Whilst drilling was being completed at the Mercuri deposit, Norwest planned additional RC holes (BRC21013 to BRC210015) to be drilled immediately along strike and up dip of BRC21001.

Norwest has now received the assay results for these three holes. Hole **BRC21013**, located 40m NE along strike of BRC21001 returned **6m @ 11.8g/t Au from 218m** and **BRC21015**, located 70m along strike and 20m up dip of BRC 21001 returned **16m @ 7.3g/t Au from 194m** with this hole ending in high-grade gold mineralisation of 18.5g/t Au at 210m.

With BRC21014 showing no significant mineralisation, analysis is being undertaken to understand if this hole was ended short of the gold mineralisation zone.

Significant gold intersections for the RC drilling at Bulgera are listed in Table 1 and shown in cross sections 1 to 3 below.




Figure 2 – Cross Section 1 with high-grade intercept in hole BRC21015. See map Figure 5




Figure 3 – Cross Section 2 with high-grade intercept in hole BRC21013. See map Figure 5




Figure 4 – Cross Section 3 with high-grade intercept in 'Discovery Hole' BRC21001. See map Figure 5

RC Drilling below the Mercuri open pit

The recent RC drilling below the shallow Mercuri open cut intersected multiple low to moderate grade gold lodes having widths from 1m to 9m. The multiple intercepts in most of the new Mercuri RC holes can be extended up dip and connected to gold intercepts encountered in past drilling programmes. Although the Mercuri gold tenor to date averages between 1g/t and 2g/t, the multiple loads have the potential to generate high tonnages per vertical metre.




Figure 6 – Cross Section 1 with multiple intercepts in holes BRC21009 and BRC20037. See map Figure 8




Figure 7 - Cross Section 2 with multiple intercepts in holes BRC21011. See map Figure 8




Figure 8 – RC collar positions for deep RC drilling below the Mercuri deposit. With cross section locations.

Bulgera overview

The Bulgera gold trend is the extension of the Plutonic (+5.5moz)³ and Vango (+1moz)⁴ maficultramafic mine sequence where drilling has shown that gold tenor increases with depth. Nearby, Vango's drilling within the mine sequence has consistently shown that the highest gold grades are located below 100m which is evidenced by their many ASX announcements; the most recent being released on 18 February 2021⁵.

Norwest's Bulgera tenements include a near-surface gold resource of 2.9Mt @ 1.0 g/t for 93,880oz Au, with minimal historical drilling below 100m. Norwest's recently completed RC drilling program tested for extensions to known gold mineralisation by drilling +150m below the existing Bulgera and Mercuri shallow open pits.




Figure 10 – The Plutonic Well geology showing the mafic-ultramafic mine sequence (primary gold host) running along the northwest edge in contact with the granites.


Exploration

About the Bulgera Gold Project Area

The Bulgera Gold Project comprises two granted exploration licences, E52/3316 and E52/3276, covering 36.8km² over the northeast end of the Plutonic Well Greenstone Belt, 200km northeast of Meekatharra. The project is located 20km northeast of the Marymia mining centre and 48km via existing haul road from the operating Plutonic gold mine which has produced over 5.5 million ounces of gold since 1990. The Plutonic mine is owned by Toronto listed Superior Gold Inc. (TSX-V:SGI).

The project contains four shallow open pits that have undergone two phases of mining between 1996 and 1998 and again between 2003 and 2004. Mining of the four pits being Bulgera, Mercuri, Venus and Price produced a reported 440,799 tonnes of ore (a) 1.65 g/t Au for 23,398 ounces. The ore was treated at the Marymia mining centre during the first phase and the Plutonic processing facility during the second phase.



Bulgera Gold Project location map

The Bulgera greenstone package has been interpreted as a faulted extension of the Marymia mine sequence across a system of curved thrusts where Marymia and Bulgera are offset. This is supported by the similarity in lithologies between the deposits and the magnetics which show the drag of the Bulgera trends into the interpreted fault structures⁶.

Norwest Minerals Limited – Bulgera RC Drilling Update, May 2021

Vango Mining Ltd (ASX: VAN) is aggressively exploring the Marymia tenements along the mafic-ultramafic mine sequence where they have made a number of high-grade gold discoveries including the Trident deposit being 1.59Mt @ 8g/t gold for 410,000 ounces. In June 2020 Vango announced a 1moz Marymia resource.


The Bulgera Gold Project location is endowed with infrastructure including the large Plutonic Gold Mine operating nearby, 2 x gas-fired power stations, overhead transmission power lines, bore fields, airstrip and camp facilities.

Norwest acquired the Bulgera Gold Project for \$220,000 in July 2019 and in September 2019 reported a JORC resource of 2Mt @1.03g/t gold for 65,500 ounces.

Following Norwest's maiden RC drilling programme at Bulgera in December 2019, the Gold Resources were upgraded in April 2020 to:

Where possible, drill holes at Bulgera were angled to the southeast (142⁰), which is roughly across strike of the mineralization and is generally considered the optimal drill orientation for this deposit. No orientation bias has been identified in the Bulgera data. Due to restrictions with positioning collars in the field hole orientations had to be changed from the optimal 142^o. These seven holes were orientated between 144^o to 201^o. There may be a slight orientation bias associated with BRC21013 and BRC21015.
