Cleansing Notice - NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS Act

Adriatic Metals PLC (ASX:ADT, LON:ADT1) ("Adriatic" or "the Company"), confirms that on 11 May 2021 it completed the issue and allotment of 1,038,600 new Ordinary Shares in the form of Chess Depository Interests ("CDIs"). The CDIs were issued pursuant to the exercise of employee performance rights.

The Company gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act) that:
