Issue of Shares & Cleansing Notice

This notice is given by Vonex Limited ("Vonex" or the "Company") (ASX: VN8) under section 708A(5)(e) of the Corporations Act 2001 (Cth) ("the Act").

On 13 May 2021, the Company issued 121,526 ordinary shares to an adviser of the Company in lieu of cash consideration at a deemed issue price of \$0.161 per share.

The shares referred to above have been issued without disclosure to the adviser under Part 6D.2 of the Act.

The Company also advises that as at the date of this notice:

1. The Company has complied with the provisions of Chapter 2M of the Act as they apply to the Company;
2. The Company has complied with section 674 of the Act; and
